Delivery of plans

The cost of plans delivery is included in the price you pay for your plans. There is no additional charge

All plans to clients within Australia are delivered by normal mail services. These are safe, fast and reliable, and in most cases you will have your plans within 2 days of their being sent. Even in the most remote parts of Australia, delivery rarely takes more than a few days, unless dependent upon periodic transport services (remote mining communities etc).

Full plans costing \$1000.00 or more are sent to clients outside Australia by Express International Courier. We have found that in many countries normal postal services are simply not reliable, and we use Express Courier to ensure that your plans arrive safely. **Courier delivery MUST be to a street address, as the plans must be signed for by you or your representative. We cannot send to a Post office box or Mail Service.** If you are only able to provide a post office box address we will only be able to send your plans by normal airmail post, and cannot guarantee delivery.

Full plans costing less than \$1000.00 are sent to clients outside Australia by standard international Airmail, due to the high cost of courier delivery. Should any plan go astray in transit, we will replace it.

Study Plans and miscellaneous items such as data disks are sent to overseas clients by standard airmail. Due to the minimum weight categories for courier items, sending small items by courier is not practical, as small, light items attract exorbitant rates, often more than the value of the item itself.

We attempt to send all orders within 2 (working) days of receiving your complete and signed order, although this may vary in unforeseen circumstances.

Refund

We are happy to replace plans or plan sheets where they are found upon arrival to be damaged or incomplete.

We are able to refund on full plans only where it is demonstrated that they do not meet our advertised claims. We are not able to refund simply because you change your mind, so please choose your plans carefully. The purpose of study plans is to give a broad overview of the boat before you commit to the full plans, and we are always happy to answer questions.

We are not able to refund on study plans, as we charge only a nominal cost of providing these plans.

CONDITIONS OF SALE

All Plans sold by Mike Waller Yacht Design are sold subject to the following conditions:

1. Copyright in all plans and associated matter remains with Michael D. Waller or Mike Waller Yacht Design. Your purchase price gives you only the right to use the information on those plans.
2. Plans are sold on the understanding that one boat only will be built from any given plan set.
3. Plans are sold on the understanding that any boat built will be built in accordance with the plans.
4. Neither Michael D. Waller nor Mike Waller Yacht Design accepts responsibility for any vessel where the Builder chooses to vary the vessel from the plan in any significant way without prior written approval from the Designer.
5. Liability of Michael D. Waller and Mike Waller Yacht Design is limited to the price paid for the plans.
6. The fee charged for full stock plans includes backup to the extent of advice on the construction of the vessel as per plan, but does not include personal supervision, nor additions nor alterations to the plans as designed.
7. Plans may not be re-sold, copied or otherwise disposed to a third part without express written Authority from Mike Waller Yacht Design.
8. The designer reserves the right to add to, alter the contents of, or withdraw from sale, any plan at any time.
9. The designer reserves the right to decline any sale at any time. If any sale is refused, any monies paid by that client for those plans will be refunded in full to that client.
